

Information on the rights set out in the General Data Protection Regulation (GDPR) (Art. 12 et seq. GDPR):

Legal basis for data processing

The legal basis for the processing of your personal data is your voluntary consent in accordance with Art. 6 para. 1 sentence 1 lit. a) GDPR.

Data collected

As part of the registration for the annual conference of the Modelling Network for Severe Infectious Diseases (MONID), the following personal data or types of personal data are collected:

- Name, first name, email address, research network affiliation, institutional affiliation, billing address, method of nutrition, for the purposes of organising, running and billing the event.

Purposes of data processing

The data you provide when registering for a network event will be used for the proper organisation, implementation and billing of the event and to contact you in order to inform you about network events and to provide you with information about network activities.

Duration of data processing and storage

Your data will be processed or stored for the duration of the project (i.e. without a fixed end) and will be stored for a further year after the end of the project for the purpose of project processing.

Transmission to third parties/abroad

Data will not be transferred to third parties or abroad. Internally, your data will be passed on for the proper realisation of the project. Your personal data will be forwarded to the responsible financial/third party funding department of the university for the proper accounting of the project, in particular the network events.

Data subject rights

You have the right to request information about the personal data we hold relating to your person at any time (Art. 15 GDPR). In addition, you have the right to rectification (Art. 16 GDPR), erasure (Art. 17 GDPR), restriction of processing (Art. 18 GDPR), data portability (Art. 20 GDPR) and objection (Art. 21 GDPR).

Consent to the processing of personal data and the right to withdraw this consent

The processing of your personal data is only lawful with your consent (Art. 6 GDPR). Consent is voluntary. You have the right to withdraw your consent to the processing of personal data at any time without giving reasons. However, the withdrawal of consent does not affect the

lawfulness of the processing based on the consent prior to its withdrawal. You will not suffer any disadvantages as a result of withdrawing your consent. In case of withdrawal, the personal data must always be deleted (Art. 7 para. 3 GDPR).

Right to complain

Without prejudice to the foregoing rights and the possibility of asserting other legal remedies, you have the right to lodge a complaint with a supervisory authority at any time, in particular in the Member State of your habitual residence, place of work or where the alleged infringement took place, if you consider that the processing of personal data relating to you is in breach of data protection regulations (Art. 77 GDPR).

Obligation to provide personal data

There is no obligation to provide your personal data. This is done voluntarily based on your prior consent. Unfortunately, if you do not provide your personal data when registering for an event organised by the network, you will not be able to participate in our event.
